**Funding Date** : - 18 Days from the date of proposal approval

An GCFF Independent Regional External Consultant will visit all project to conduct capacity assessment before any funding or disbursements are made to successful applicants.

Upon approval, the successful applicants will be invited to grants management training which will be fully funded / supported by GCFF.
